

MANITOBA MUDRUN WAIVER & RELEASE OF CLAIMS, ASSUMPTION OF RISK AND CONSENT TO MEDICAL TREATMENT ("WAIVER")

Manitoba MudRun ("Event") is a registered business name of Manitoba MudRun Inc.

PLEASE READ THIS DOCUMENT CAREFULLY AS IT AFFECTS YOUR FUTURE LEGAL RIGHTS AND PROVIDE YOUR INITIALS ON EACH LINE AFTER READING

As Used herein, the term "Release" is defined to include: (i) Manitoba MudRun Inc., its owners, , past and present employees, members, directors, officers, agents, representatives, affiliated companies, successors and assigns; (ii) The Dauphin Rotary Club; members, directors, officers, agents, representatives, affiliated companies, successors and assigns (iii) event volunteers, (iv) the owner of the property where the Event occurs, including, but not limited to, The City of Dauphin, James Crozier, Ukrainian Folk Arts Center; and (v) any Event sponsors or advertisers, and each of their respective owners, members, directors, officers, past and present employees, agents, representatives, affiliated companies, successors and assigns.

- ___ 1. I understand that the Event is an inherently dangerous activity that presents extreme obstacles, including, but not limited to, mud pits, barbed wire, cargo nets, , heights, climbing, free falls, water crossings, swimming, steep hills, and/or uneven terrain.
- ___ 2. I understand that participating in the Event involves the risk of severe physical injury and/or death that cannot be completely eliminated.
- ___ 3. I voluntarily, knowingly and freely assume all risks associated with competing in the Event, including, but not limited to, my own actions or inactions, the actions or inactions of others (including participants, spectators and Releasees), falls, injuries, illnesses, infections, contact with others, completing any and all obstacles, premises defects and the effects of weather, including but not limited to, heat and/or humidity.
- ___ 4. I understand, agree and accept that some of the obstacles may go through water that has not been tested for chemicals, diseases or contamination.
- ___ 5. I understand that the Event course may contain wild animals, insects and plants.
- ___ 6. I agree not to dive into or enter any mud pit or water obstacle head first, as doing so may cause serious physical injury and/or death.
- ___ 7. I certify that I am physically fit and have no medical condition that would make participation in the Event more hazardous.
- ___ 8. If I am pregnant, disabled in any way or have recently suffered an illness or injury, I should have or did consult a physician before participating in the Event.
- ___ 9. I attest that on the date of the Event I will possess and be covered by medical insurance, individually or as part of an organization.
- ___ 10. I consent to medical care and transportation in order to obtain treatment in the event of injury to me as Manitoba MudRun Inc., volunteers or medical professionals may deem appropriate and understand that this Waiver extends to any liability arising out of or in any way connected with such medical treatment and transportation provided in the event of an emergency and/or injury.
- ___ 11. I agree to observe and obey all posted rules and warning, to follow any instruction or directions given by Manitoba MudRun Inc. through its volunteers, representatives or agents, and to abide by any decision of any Event official relative to my ability to safely attend and participate in the Event.
- ___ 12. I understand and agree that I am expected to exhibit appropriate behaviour and to obey all local, provincial and federal civil and criminal laws at all times while participating in or attending the Event. This includes, generally, respect for all people, equipment, facilities or property. Manitoba MudRun Inc. may dismiss me, without refund, should my behaviour endanger the safety of or negatively affect the Event, person, facility, or property and I agree to indemnify the Releasees from any and all third party claims caused in whole or in part by my negligence, gross negligence or intentional acts or omissions.
- ___ 13. I agree not to consume alcohol prior or during the Obstacle portion of The Event or use any medicine or substance that will inhibit my mental or physical ability to safely participate in the Event. I also agree that if I consume alcohol at the event, I shall do so responsibly and only if I am over the minimum legal drinking age.
- ___ 14. I agree that Manitoba MudRun Inc. is not responsible for any personal items or property that is lost, damaged or stolen at the Event.
- ___ 15. I understand that pets, wheeled baby conveyances or other wheeled means of conveyance are not permitted on the Event course.
- ___ 16. I consent to the use of my image in photographs, motion pictures, or recordings taken at the Event for use in Event advertising, marketing or promotion.
- ___ 17. I assign all rights, title, and interest in any and all photographs, motion pictures, recordings or other records of the Event I may take or capture to Manitoba MudRun Inc. Manitoba MudRun Inc. grants to me a limited, non-exclusive, perpetual right and license to use, for non-commercial purposes only, any and all photographs, motion pictures, recording, or other records of the Event I may take or capture.
- ___ 18. I agree that all entry fee payments are final and non-refundable.
- ___ 19. I agree that Manitoba MudRun Inc. reserves the right to cancel the Event in the event of weather (including, but not limited to, heat, tornadoes, earthquakes, fires, storms, lightning and floods), accidents, acts of war or terrorism, military conflicts or riots or for any reason that, in Manitoba MudRun Inc's discretion, will protect the safety and security of Event participants and spectators. In the event of such cancellation, there will be no refund of my registration fee.
- ___ 20. I agree that this Waiver is intended to be as broad and inclusive as permitted by the laws of the Province of Manitoba, and that if any portion is held invalid, the balance shall continue in full legal force and effects.
- ___ 21. I understand and acknowledge that the laws of the Province of Manitoba shall apply to all matters relating to this Waiver of the Event location, that the exclusive jurisdiction for any dispute with the Releasees resides in Provincial or Court of Queen's Bench in Dauphin, Manitoba and I expressly consent to the exercise of personal jurisdiction in the Province of Manitoba in connection with any dispute with the Releasees from my Event attendance or participation.
- ___ 22. (Check One) ___ I am at least 18 years old OR ___ I am at least 12 years old and my Parent/Guardian has reviewed this Waiver and consented to its terms.

I release, waive, discharge, absolve, indemnify, agree to hold harmless and covenant not to sue the Releasees for any claim arising out of any injury to me (or my child) and from any and all claims, causes of action, obligations, lawsuits, charges, complaints, controversies, damages, costs or expenses of any kind, nature, or description, whether direct or indirect, in law or in equity, in contract or in tort, or otherwise, whether known or unknown, arising out of or connected with my (or my child's) attendance at and participation in the Event, whether or not caused by the Releasees' negligence or gross negligence.

___ I acknowledge that I have read and fully understand the important information above, that I have carefully analyze, accepted, and agreed to all terms herein, that I sign on my own free act and deed and that I understand that I have given up legal rights by signing below.

___ I acknowledge that this Waiver is consideration for permission to participate in the Event and my participation in the Event WILL BE DENIED if my signature (or the signature of my parent/guardian if I am under the age of 18) does not appear on this Waiver prior to my participation in the Event.
